Who we are

Where we collect personal information

When you give us your information directly. Examples include:

- Through email
- Through social media
- Request to a SFTG member

When your information is available publicly. Examples include:

- MP or Councillor status
- Schools
- Businesses
- Churches

What personal information we collect

The information we collect and store is minimal:

- Email address
- Postal address
- Telephone number
- Social media links

How we use your personal information

We may use your personal information in the following ways:

- To inform supporters about an upcoming event
- To inform traders about an upcoming event
- To send out our newsletter
- To request help from volunteers
- To offer support for Fairtrade initiatives
- To occasionally make contact for another reason connected to Fairtrade

We **never** use your personal information for:

- Marketing purposes
- Selling on to a third party
- Using the services of a third party
- Analysis or profiling

How we keep your personal information safe and who has access to it

Only authorised SFTG members have access to your personal information and it is never shared outside the group without your consent.

However, the nature of information transfer - particularly online - is **never fully secure**, so we cannot guarantee the complete security and protection of it when it is outside of our control.

There are times when our emails to you or our website may contain links to other **external sites**. We try to ensure that these organisation's sites are respectable, but we are not responsible for their privacy policies. There may be information that can personally identify you. Check their privacy notice to learn more.

We will comply with legal requests to **disclose** your details as permitted by law to the police, Government and regulatory bodies or legal advisors if required.

How long we keep your personal information

We will keep your personal information indefinitely unless you otherwise advise us.

How to access, correct or delete your personal information

We will endeavour to amend or update your contact details and communications preferences as soon as possible after you make your request.

We will review and update this privacy policy at our discretion. We will post on our website and contact you directly, if possible, to make you aware of any significant changes to the way we treat your personal information.

Unless you let us know otherwise, SFTG will assume that you agree with updates to the privacy policy.
